Margins

Tables

All tables should be numbered continually (above the table, including also the title of the table, font size 12, source should be below the table, font size 10). Tables should be mentioned in the text. Word editor should be used to create the tables. Tables should contain a unit of measurement.

Figures

All figures should be numbered continually (above the figure, including also the title of the figure, font size 12, source should be below the figure, font size 10).

References

Please use the footnotes in the paper (name of the author, year of publ., title of the book, page - font size 10).

Place the references at the end of the manuscript in the alphabetical order. The list should mention only those sources actually cited in the footnotes. Authors name should be same as in the original source.
